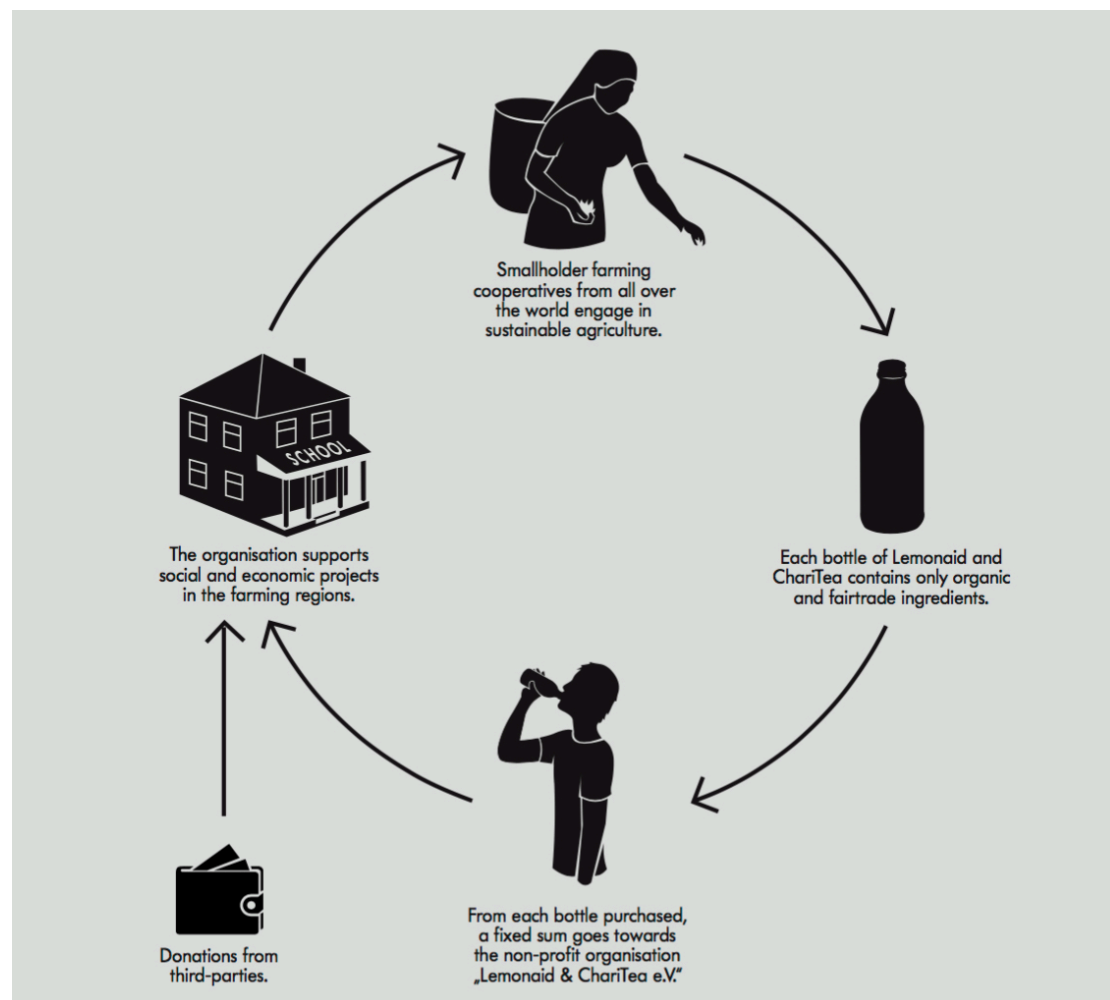


SUPPORTING MEMBERSHIP - LEMONAID & CHARITEA E.V.

The organisation aims to help others to help themselves, as a contribution to the sustainable improvement of social, economic and ecological structures in regions which face many disadvantages in the global economy. Many problems in the so-called “third world” can be solved with the autonomous participation of local people. Therefore the organisation supports projects that encourage political, economic and cultural participation.

In this way, educational projects offer young people better long-term career perspectives; cooperative, organic farming helps farmers earn a livelihood independently of large-scale landowners. Because local people are best-placed to know where support is most urgently needed, the organisation focuses its funding on small, local organisations and initiatives. To date, more than a million euros have been raised for development projects.
